

### About the Supported Registration Scheme (SRS)

SRS is designed to help you reach professional registration as a Chartered or Incorporated Engineer. By adopting SRS, your company has committed to helping you further your engineering competence, from your first placement to your final professional registration in line with the competences set out by the Engineering Council's UK Standard For Professional Engineering Competence (UK-SPEC)

#### **About Career Developer**

Career Developer is the Institution of Mechanical Engineers' (IMechE) online portal that allows engineers to manage their professional development. Under the SR Scheme, you'll submit quarterly reports and annual assessments against planned objectives that will be scored against UK-SPEC by a mentor. This report structure ensures you receive regular quarterly feedback, essential to your progression.

#### Your mentor

You may be assigned a mentor by your company to guide you through SRS. Mentors are engineers within your company, or in a similar field to you, who have agreed to help you plan and reach your personal objectives. Unlike MPDS, SRS Mentors do not need to be professionally registered. Through regular face-to-face meetings and scheduled submissions, you'll learn more about the UK-SPEC competences you'll be working towards each quarter and how best to meet them.

If you're finding your professional development difficult, you can discuss your training and development with your mentor. Your mentor is committed to helping you achieve your competence, so if they are continually unavailable or on extended leave, you may wish to find a replacement mentor. #### Registration

You must complete an IMechE SRS Registration Form to be formally registered on the Scheme. You can register onto either the CEng or IEng route. If you are not sure which route to register on, please contact us at SRS@imeche.org.

Once registered, you must make sure your membership of IMechE stays up to date. If you fall behind with your subscription fees, your account will be lapsed. If you transfer to a new company, please complete a new SRS Registration form as this will ensure that your latest details are kept on record.

Should you transfer to a company with an accredited scheme in place, you can continue reporting from where you left off by completing the MPDS registration form.

#### Overview

The MPDS/SRS tools have many features that allow you to record your Initial Professional Development (IPD) as effectively as possible. You can use the tool to simply submit the compulsory SRS Quarterly Reports and Annual Assessments, or as a more fulfilling development programme with the capability to plan, record and provide evidence against competences. Everything you submit to SRS forms part of your application for professional registration and should be supported by regular face-toface meetings with your mentor.

You must make sure you submit your reports and assessments within two months of the due date to ensure that you stay up to date. Any Further Learning should also be completed whilst on SRS so your application for professional registration isn't delayed. Your submissions are scored against five main areas of competence. Your mentor will help you plan your compulsory Quarterly Reports and Annual Assessments effectively in order to meet the requirements set out by the Engineering Council.

#### **Previous Experience**

This is a term that relates to MPDS only. With SRS there is no minimum requirement and therefore you can apply for professional registration whenever you and your mentor feel that you have met the requirements for Chartership.

Developing Engineers will be placed in Year 1 Quarter 1, unless specifically advised by your mentor.

### Scoring for UK Standard for Professional Engineering Competence (UK-SPEC)

There are four levels of scoring that your mentor may use to assess you as a Chartered or Incorporated Engineer:

Level 1 Aware	Level 2 Familiar

#### How the scores work

Each assessed piece of work that you submit will be graded using the above levels, based on UK-SPEC's five competences. Once you have completed SRS, your mentor will assess the final scores you have been awarded to decide whether your application for registration is appropriate. Your competence will be assessed by the IMechE through the membership application process and Professional Review Interview.

#### Using the MPDS/SRS tools is simple

Log in to your account at www.imeche. org/ careerdeveloper or enter your IMechE username and password in the log in fields in the top right hand corner of any page of the IMechE website, navigate to Your Professional Development and then click MPDS/SRS Tools for Developing Engineers. If you have any trouble logging in to the tools, email SRS@imeche.org

Once logged in, you will be able to view your SRS status. Make sure that your SRS year and quarter are correct.

If any of these details are incorrect, email SRS@imeche.org for an update.



These areas form the basis of your SRS and each allow you to record and submit your progress. They are designed to guide you through each quarter and year and allow you to pull together your submissions ahead of your Annual Assessment. It is highly important to develop a good reporting style through regular submissions. By building a record of competence, you are demonstrating your skills and knowledge base, which will be used as part of the application for professional registration.

### **Quarterly Reports and Annual Assessments are compulsory elements of SRS.**

Quarterly Reports and Annual Assessments are compulsory elements of SRS.

For years one and two on the scheme, you will need to submit three Quarterly Reports, each around 200-500 words long providing a summary of what you've contributed and learned each quarter, including what you learned from errors and failures.

This will be followed by an Annual Assessment which provides an overview of quarter four, the year as a whole and your mentor's report of competence against UK-SPEC. In years three (usually the final year for those on the IEng route) and four (usually the final year for those on the CEng route) on the scheme, you will need to submit at least one Quarterly Report for quarter two and an Annual Assessment in quarter four. Submitting a Quarterly Report for quarters one and three is optional.

#### **Quarterly Reports**

These reports form the basis of your submission for professional registration and are designed to show that you have been monitored, you have achieved professional competence and are committed to engineering.

#### To create a Report

- 1. From the Quarterly Report tab, click on your current Year and Quarter and the report template will open.
- 2. Type your report (up to 500 words) or copy it in from another document. If you haven't submitted Evidence this quarter, you can match your paragraphs more visibly to UK-SPEC by using the competence codes (e.g. B1, D2 etc).
- 3. Once you are happy with the submission, click 'Save'.
- 4. You can then click 'Submit to Mentor' if you are ready to send it to your mentor.

The objectives and competences assigned to any plans and evidence submitted during this quarter will automatically be added to your report once they have been accepted by your mentor.

#### **Annual Assessments**

Your Annual Assessment is a summary of quarter four, the year as a whole and how you achieved the competences set out in UK-SPEC. This should be submitted and approved by your mentor within two months of the due date. You must complete your Annual Assessment for the year before moving onto the next Quarterly Report.

#### To create an Annual Assessment

- 1. From the Annual Assessment tab, click on the current year and the Annual Assessment template will open.
- 2. Any UK-SPEC competences covered this year will appear if you have submitted evidence.
- 3. Under each of the competence headings (A-E) list the activities you have carried out and how you have achieved these competences don't leave these areas blank or your mentor will be unable to assess you.
- 4. Complete your personal evaluation of the year.
- 5. To ensure your comments are saved, please click 'Save'.
- 6. You can then click 'Submit to Mentor' if you are ready to send it it to your mentor. You won't be able to amend this unless your mentor returns it to you for revision.

Your mentor will then score your competences and fill in four questions relating to the report before signing it off by accepting the submission.

#### Plans

Whilst creating Plans are optional, they can add valuable content to your reports and are highly recommended in your third and fourth years. Use one Plan per quarter to outline your aims, objectives and competences.

#### To create a Plan

- 1. Under the Plans tab, click on the current Year and Quarter and the Plan template will open.
- 2. List your objectives for the quarter.
- 3. Link competences to your plan by pressing "Click to add competences". You can add more than one competence at a time.
- 4. To ensure your work is saved, click 'Save'.
- 5. If you would like your mentor to review and add their comments to this, click the 'Submit to Mentor' button.

The Plan is then sent to your mentor for review. They will check the competences you have selected and then either approve it if they are happy or return it with comments for you to revise before submitting again.

You should focus on the objectives and competences you have chosen for that quarter. If you don't achieve all of them, you can revisit them in the next quarter.

#### Evidence

Whilst working towards your registration, you will take part in a range of activities such as project roles, quality management, financial budgeting, various courses and risk assessments which will all help build your competence. You will address the various competences of UK-SPEC several times because you gain competence by doing things over and over again, and you can record these activities as part of your portfolio of evidence.

As your SRS record is portable and the nature of the projects you work on is likely to be confidential, you should avoid uploading sensitive company documentation. Instead, you can make brief notes to outline how you achieved the competences within each Plan and these can be mapped automatically to your Quarterly Reports.

#### To submit Evidence


- 1. Under the Evidence tab, click on the 'Add New' button and an Evidence template will open.
- 2. Give your Evidence a title, year and quarter and select the type of evidence category from the dropdown menu (e.g. project or report).
- 3. Upload your Evidence or specify a physical location where your Evidence can be found.
- 4. Enter your brief comments in the DE comments field.
- 5. Link the competences you achieved during this period, by clicking 'Add competences'. You can add more than one competence at a time. Click on 'Save & Close'.
- 6. If you would like your mentor to review and add comments to this, click 'Save' then 'Submit to Mentor'.

You can submit up to 8 pieces of Evidence each quarter.

When you have completed your final Annual Assessment and your mentor has agreed that you have completed your reporting, this normally indicates that you've completed IPD and reached an appropriate level of competence within the UK-SPEC criteria for your path. However, this depends on you having had sufficient opportunity to develop competence and whether you are actually working at CEng or IEng level. Your mentor will help agree this with you.

If you or your mentor feels you are not quite ready for registration, you should continue recording your development. To ensure that your scheme is extended, you or your mentor should email us at SRS@imeche.org with your full name, membership number and duration of the extension in quarters. You can report up to a maximum of Y6Q4. The content in your next quarterly report could make all the difference at your professional review so carry on completing them until you're ready for registration.

#### Applying for Professional Registration -CEng MIMechE or IEng MIMechE

When you are ready to apply for professional registration and full membership, you should complete the online application form available from the My Account page. This can be found in the section 'Online Applications'. Please then go to 'Online Application Checker'.



As a member, you'll be expected to continue your commitment to engineering through Continuing Professional Development (CPD). Your mentor will discuss the IMechE Code of Conduct with you and can help you with your CPD. As part of your CPD, you can become an MPDS or SRS mentor and ensure that professional engineering standards are maintained through mentoring graduate engineers.
